### DUSK-TO-DAWN RENTAL LIGHT REQUEST AND CONTRACT FOR SERVICES

The above name CUSTOMER and the BOARD OF PUBLIC WORKS, the Electric Utility Authority within the City of Hannibal, Missouri, hereafter referred to as "BPW", hereby agree to the following terms in connection with the provision of a rental light at the above noted location:

- 1) The BPW shall install, repair, maintain and service a 175-watt dusk-to-dawn, mercury vapor, outside light at the above requested location.
- 2) The BPW shall charge a rental rate per month. This rate will become a part of the CUSTOMER'S monthly utility bill and subject to the same payment terms.
- 3) The BPW shall not provide more than one (1) rental light per property and shall have the right to terminate this Rental Light Contract should the light be subject to excessive lamp failures due to the effects of vandalism, repeated damages or other conditions at the location which would require excessive maintenance costs as determined by the BPW.

The CUSTOMER further warrants and agrees that:

- 1) It has the right to grant access to the BPW to the subject location for purposes of installing, maintaining, operating and removing the rental light.
- 2) That the terms of this agreement for the rental light shall be four (4) years, said term commencing with the installation of the rental light.
- 3) That any malfunction of the light shall be reported to the BPW and only BPW Personnel shall make the repairs as soon as the current workload permits. The monthly charge shall not be prorated for any period of non-service.

- 4) The BPW's rental lights are provided to the CUSTOMER as a convenience only and are not guaranteed, warranted or intended to provide protection from theft, vandalism, etc.
  
- 5) That the BPW, its personnel and the City of Hannibal shall not be held responsible for operation of the rental light nor shall said BPW be held responsible, financially or otherwise, for any conditions, developments or other circumstances which may arise as a result of the operation and / or failure of the rental light.

This request for a rental light is made by the undersigned CUSTOMER and this signature attests to the fact that said CUSTOMER has read, understands, and agrees to the terms of this Contract and the current Rental Light Policy in place by the Board of Public Works (policy copy is attached).
