SEWER RATE SCHEDULE

Effective with usage beginning July 1, 2016

GENERAL RATE PROVISIONS

Connection Charges

Connections to HBPW sewer mains, service laterals, meters and their installation, if applicable, are the responsibility of the customer. A connection or transfer charge as published in the Schedule of Fees and Charges will be charged for all new connections or transfers.

Extension of Mains

Sewer mains may be extended by private developers with approved plans and using HBPW approved materials and construction methods. Sewer mains may be extended by HBPW. HBPW construction will be charged as published in the Schedule of Fees and Charges.

Billing

Bills will be the sum of Monthly Customer Charges, Usage Charges, and surcharges, if applicable. All bills will be rendered monthly and shall be payable at net through the due date shown on the bill. Bills paid after the due date shall be subject to a late payment penalty as determined in the HBPW Schedule of Fees and Charges.

Delinquency and Disconnection of Services

If any bill is unpaid after the due date, the customer will be considered delinquent and water or electric service is subject to disconnection. Reconnection charges as determined in the HBPW Schedule of Fees and Charges shall be paid by the delinquent customer before service is restored. Refer to the Disconnection Policy, for more detail.

Sales and Use Taxes and Transfer Fee

The current Missouri Sales and Use Tax, County, and City Sales Tax applicable to nonexempt service rendered will be added to the monthly bills calculated under these rate schedules. A 5% City Transfer Fee will be added to the monthly bills.

2 Rivers Industries, Inc. Fee

The current 2 Rivers Industries, Inc. Fee will be added, if applicable, to the monthly bills calculated under these rate schedules until December 31, 2017. (*Note: This fee was previously known as NE Mo Sheltered Workshop.*)

Service outside Hannibal City Limits

Service outside the City limits of the City of Hannibal is subject to a surcharge of 100% on the monthly customer and usage charges.

Rate Class Assignment

Rate classification for new accounts will be assigned based on projected usage information furnished by the customer. Existing accounts will be reviewed by the HBPW for classification changes in June of each year based on the prior 12 months of usage history and the existing rate schedule. Classification changes will be effective with the July Billing.

Industrial Pretreatment

Discharges are subject to the City’s Industrial Pretreatment Program pursuant to Chapter 25, Article V of the Code of Ordinances.

Loading Limits and Extra Charges

Discharges to the sewer system containing excessive Biochemical Oxygen Demand (BOD) or Total Suspended Solids (TSS) are subject to the following charges:

BOD	greater than 255 mg/L	\$0.165/lb
TSS	greater than 240 mg/L	\$0.175/lb

To comply with the 2013 Series Bond Covenants the following rates and changes for future years have been programmed into the financial model of the Hannibal Board of Public Works. The Board reserves the right to revise this Schedule in future years as required to respond to unknown events. But in no event shall these programmed adjustments be lowered.
