Administration / General

City Transfer Fee: 5% of demand and usage charges

Definition: A municipal fee charged to HBPW by the City of Hannibal for the right to bring utilities across city property in order to serve the customer. We are required to list this fee separately on your bill. The fee becomes a part of the sales price for utilities for sales tax purposes and is subject to state and local use tax in the same manner as the utilities themselves.
