**TRANSFER FEE**

As established and defined by City Charter and City Ordinance Number 4834 which was approved by City Council on June 16, 2020, a Transfer Fee of 5.5% shall be applied to all utility usage charges effective July 1, 2020.

*City Transfer Fee Definition:* A municipal fee charged to HBPW by the City of Hannibal for the right to bring utilities across city property to serve the customer. We are required to list this fee separately on your bill. The fee becomes a part of the sale price for utilities for sales tax purposes and is subject to state and local use tax in the same manner as the utilities themselves. This percentage fee is for all HBPW supplied municipal services.

The information throughout the remainder of this document outlines various charges and fees for services either collected by HBPW or services offered by HBPW.

**RECYCLING FEE**

Voters approved a Recycling Fee on June 2, 2020, to be billed and collected through the HBPW utility billing process. According to Proposition R, the Recycling Fee will be charged on each utility bill issued by HBPW for service provided within the City limits of Hannibal, MO.	\$1.90 per account per month

## **GENERAL RATE PROVISIONS**

### **Connection Charges**

Connections to HBPW water mains, sewer mains, service lines, meters and their installation are the responsibility of the customer. A connection or transfer charge as determined above will be charged for new connections or transfers.

### **Extension of Mains**

Water and sewer mains may be extended by private developers with approved plans and using HBPW-approved materials and construction methods. Water and sewer mains may also be extended by HBPW. HBPW construction will be charged as published above.

### **Billings**

All bills will be rendered monthly and shall be payable at net through the due date shown on the bill. Bills paid after the due date shall be subject to a late payment penalty as determined above.

### **Delinquency and Disconnection of Services**

If any bill is unpaid after the due date, the customer will be considered delinquent, and service is subject to disconnection. Reconnection charges as determined above shall be paid by the delinquent customer before service is restored. Refer to the Disconnection Policy, for more detail.

### **Sales and Use Taxes and Transfer Fee**

The current Missouri Sales and Use Tax, County, and City Sales Tax applicable to nonexempt service rendered will be added to the monthly bills calculated under these rate schedules. As defined above, a City Transfer Fee on usage and demand will be added to the monthly bills.

### **Service Outside Hannibal City Limits**

Electric service outside the city limits of the City of Hannibal is subject to a surcharge of 40% on the monthly usage charge. Water and sewer service outside the city limits is subject to a surcharge of 100% on the monthly customer and usage charges.

### **Resale**

Service shall not be taken under these rate schedules for the purpose of resale. HBPW reserves the right to refuse service to customers not in compliance with this provision.

### **Interference**

Use of electric service which causes disturbances on the electric distribution system and interference with service to other customers will not be allowed. HBPW reserves the right to refuse service to customers not in compliance with this provision.

### **Adherence to Codes and Rules**

Connected wiring, electrical installation, and equipment must be in accordance with applicable electrical codes and the rules of the HBPW. The HBPW reserves the right to refuse service to customers not in compliance with this provision.

### **Rate Class Assignment**

Rate classification for new accounts will be assigned based on projected usage information furnished by the customer. Existing accounts will be reviewed by the HBPW for classification changes annually based on the most recent prior 12 months of usage history and the existing rate schedule. Classification changes will be effective as soon as administratively feasible. Customers in the Industrial and Commercial classes may apply for a rate class re-assignment as their business plans change to become effective with the July billing each year.



### **Power Factor Correction**

Customers agree to maintain average power factor as close to unity as possible. However, if a customer's average power factor is less than 95% lagging, a separate power factor correction bill will be rendered monthly. The monthly demand billing will be adjusted by multiplying the actual 15-minute demand measured during the month by the ratio of 95% to the average power factor expressed in percent. The difference between actual and adjusted demand will be billed separately.

### **Meters and Settings**

Meters and meter setting materials for new installations must be purchased from the HBPW. Refer to the HBPW Design Criteria found on the HBPW website and the fees defined above for more information.

### **Industrial Pretreatment**

Discharges are subject to the City's Industrial Pretreatment Program pursuant to Chapter 25, Article V of the Code of Ordinances.

### **Loading Limits and Extra Charges**

Discharges to the sewer system containing excessive Biochemical Oxygen Demand (BOD) or Total Suspended Solids (TSS) are subject to surcharges as defined above.

### **Primary Metering Discounts**

Discounts are available to customers choosing options listed under voltage and metering options.

### **Advanced Metering Infrastructure (AMI) Opt-Out Program**

Subject to eligibility requirements, HBPW customers may "opt-out" of the installation of an AMI meter. Customers may also elect to have their AMI meter replaced with a non-standard meter. Refer to the Program Terms and Conditions on the HBPW website and the fees defined above for more information.



**ELECTRIC RATE SCHEDULE**

**Effective with usage beginning August 3, 2021**

**RESIDENTIAL SERVICE RATE**

Available to a single-family private residence or detached garage at the same address or farm as 60 cycle, single phase service at a nominal voltage of 120 volts or 120/240 volts, furnished through one meter for domestic purposes only, including lighting, domestic appliances, heating, and refrigeration, and other uses requiring single phase motors of 7.5 hp or less.

Residential Service to a multiple family dwelling or apartment house through a single meter is allowed.

Available to any non-residential customer and includes service at one location for general service as 60 cycle, single-phase service through one meter at the secondary voltage available from the electric distribution system at the customer's location.

**THREE PHASE COMMERCIAL SERVICE RATE**

Available to any non-residential customer and includes service at one location for general service as 60 cycles, three-phase service through one meter at the secondary voltage available from the electric distribution system at the customer's location.

Customer Charge	\$50.00 per month
Minimum Bill	Same as Customer Charge

**INDUSTRIAL SERVICE RATE**

For any customer with a peak monthly energy demand during the most recent 12-month review period of 100 kW or more at any load factor, or a peak energy demand of 50 kW or more and a load factor more than 45%. Includes service at one location or multiple locations through multiple meters as 60 cycle, three-phase service, with secondary voltage as available at the customer's location.

Refer to Primary Voltage and Metering Options below.

The monthly bill shall be the sum of the demand, energy, power factor correction, and customer charges calculated according to the following schedule:

Demand Charge	\$14.33 per KW month
Energy Charge	\$0.0542 per kWh
Customer Charge	\$125.00 per month
Minimum Bill	Same as Customer Charge

**DETERMINATION OF BILLING DEMAND**

The billing demand shall be the customer's highest 15-minute demand in kW incurred during the month for which the bill is rendered. For multiple meter customers the highest co-incident 15-minute demand will be used.



**LARGE INDUSTRIAL SERVICE RATE**

For any customer with a peak monthly energy demand during the most recent 12-month review period of 1,000 kW or more. Includes service at one location or multiple locations through multiple meters as 60 cycle, three-phase service, with secondary voltage as available at the customer's location.

Refer to Primary Voltage and Metering Options below.

The monthly bill shall be the sum of the demand, energy, power factor correction, and customer charges calculated according to the following schedule:

Demand Charge	\$13.60 per KW month
Energy Charge	\$0.0514 per kWh
Customer Charge	\$200.00 per month
Minimum Bill	Same as Customer Charge

**DETERMINATION OF BILLING DEMAND**

The billing demand shall be the customer's highest 15-minute demand in kW incurred during the month for which the bill is rendered. For multiple meter customers the highest co-incident 15-minute demand will be used.

**DISCOUNT INCENTIVE PROGRAM FOR INDUSTRIAL CUSTOMERS**

New qualifying industrial customers and existing industrial customers with new qualifying loads are subject to Incentive Rates for the first forty-eight (48) months of usage according to the schedule below. To qualify, industrial customers must notify the HBPW at least 90 days in advance of the new load and must have a minimum of 70,000 kWh/month of usage.

First 12 months of Billing	60% of approved energy rate
Second 12 months of Billing	70% of approved energy rate
Third 12 months of Billing	80% of approved energy rate
Fourth 12 months of Billing	90% of approved energy rate

Qualifications will be determined by the HBPW on a case-by-case basis and will consider such things as an affirmative recommendation from the Hannibal Regional Economic Development Council, number and value of local jobs created, length and size of required distribution system extensions, and estimated annual consumption.

**VOLTAGE AND METERING OPTIONS**

Primary Voltage Metering Service is available to Industrial customers whose connected transformer size is 500 kVa or larger. Usage discounts are available to new customers upon application. Demand discounts are no longer available to new customers.

Billing discounts are available to qualified customers who choose one of the following options:

**NET METERING SERVICE**

Available to all customers of 100 kW or less capacity who offset energy delivered by the HBPW using alternative energy sources such as wind or solar. Refer to Missouri Revised Statutes Section 386.890.1 dated August 28, 2014.

Energy used by the customer more than energy delivered by the customer at the same site during the same billing period shall be billed in accordance with the appropriate retail electric rate. For a demand metered customer, the entire kW demand supplied by the HBPW at the same site during the same billing period shall be billed to the customer according to the appropriate demand charge rate. Interconnection charges will be assessed by the HBPW on an individual basis for all costs associated with addition to or modification of HBPW facilities to accommodate the customer. The voltage and phase of the customer's generator must be consistent with the existing service and approved by the HBPW. The customer must maintain a power factor of its generator as close to unity as possible consistent with HBPW operating practice.

**DISCOUNTS AND INCENTIVE PROGRAMS**

New qualifying Commercial customers and existing Commercial customers are subject to Incentive Commodity Charges for the first forty-eight (48) months of usage according to the schedule below. To qualify, customers must notify the HBPW at least 90 days in advance of the new load and must have a minimum of 200,000 gallons per month of usage.

First 12 months of Billing	60% of approved commodity rate
Second 12 months of Billing	70% of approved commodity rate
Third 12 months of Billing	80% of approved commodity rate
Fourth 12 months of Billing	90% of approved commodity rate

Qualifications will be determined by the HBPW on a case-by-case basis and will consider such things as number and value of local jobs created, length and size of required water main extensions, and estimated annual consumption.
